## **Membership Application Information**

Newcastle Reform Synagogue is a constituent member of the Movement for Reform Judaism. Membership of Newcastle Reform Synagogue is open to all Jewish people. For our purposes, this means anyone who was born to a Jewish mother or who has converted to Judaism under the auspices of any authority recognised by the Movement for Reform Judaism.

All applications for membership are referred to our Rabbi. The synagogue requires that the Rabbi be satisfied that the applicant is eligible for membership. In most cases, the Rabbi will ask to see documents which establish Jewish status. Examples would include a parents' *ketubah* (Synagogue marriage certificate), or a certificate of conversion. In the event of any doubt regarding Jewish status, an opinion may be sought from the Beit Din (Rabbinical Court) of the Movement for Reform Judaism, which the Synagogue recognises as the authority in such matters.

When the Rabbi is satisfied that an applicant is Jewish, the membership application is presented to the Synagogue Council for approval. Once approved, the Synagogue Treasurer will send the applicant information about membership, including the optional funeral expenses scheme, and a request for payment of subscriptions. In the event of financial hardship, applicants/members should consult the Treasurer. All information relating to membership, including financial information, is treated as strictly confidential.

The Synagogue Council, acting in consultation with its Rabbi and the Movement for Reform Judaism, reserves the right to refuse an application for membership or to terminate an existing membership. While always seeking to act in good faith and with due regard to natural justice, the Synagogue Council is not obliged to give reasons for its decisions.

## **Membership Categories**

There are several categories of membership for which individuals can apply. They are as follows:

- Full membership is open to adults (aged 18+);
- Country membership is open to adults who live 50 or more miles from NRS;
- Student membership is open to adults aged 18 to 24 inclusive as at 31 Dec of the year prior. A person who is over the age of 24 and is a full-time student is also eligible to apply for student membership, but must show proof of student status; and,
- Child membership is available for those aged 5 to 17 inclusive, as at 31 Dec of the year prior.

<b>Friend (single)</b>	“Friends” are aged 18+ and support the ideals and activities of NRS, but are not Jewish and, therefore, not eligible for full membership. The category of ‘Friends of NRS’ is available for (a) partners of Jewish members and (b) persons of goodwill who wish to support NRS.	<b>£160</b>
